Unlike licensing and EPA-mandated certifications, the Council-certified Indoor Environmental Remediator (CIER) and Council-certified Indoor Environmental Supervisor (CIES) distinguishes one from those required to have government-issued credentials.

Candidates may prepare for the examination at their convenience by studying accepted industry publications. There are no required courses; however, study/review courses are available from a variety of independent providers. The ACAC has no financial or revenue-sharing agreements with these course providers.

Exams are delivered electronically at secure testing facilities throughout North America and major cities worldwide. Exam results are delivered instantly; however, certification is awarded only after the CMR/CMRS certification board review and is granted by unanimous vote.

## Who Is a CIER/CIES?

**The Council-certified Indoor Environmental Remediator (CIER) and Council-certified Indoor Environmental Supervisor (CIES) is a contractor who performs remediation and/or abatement of asbestos, lead, hazardous materials, meth labs, grow houses, mold, bacteria and more.**

A CIER and CIES understands the relationships between the indoor environment and those who occupy it. They have demonstrated specialized industry knowledge and have extensive experience in performing safe, reliable renovation of areas contaminated by dangerous substances.

The CIER has at least two years of field experience in one of the specialized fields of remediation and/or abatement.

The CIES has at least five years of field experience in three of five fields of specialized remediation and/or abatement.

- Mercury spills
- Hazardous materials
- Meth lab cleanup
- Grow houses
- Mold remediation
- Bacteria remediation
